Subject Prohibiting nudity on certain public land and limiting parking in town of Mazomanie		

Assumptions Used in Arriving at Fiscal Estimate

This bill prohibits persons from parking in any DNR parking lot along Conservatory Drive in the town of Mazomanie and also for being nude in public on any stated-owned or state-controlled land. It imposes a forfeiture of up to \$250 for persons found in violation of either of these prohibitions.

The creation of additional forfeiture actions will bring more matters before the courts. It is impossible to predict how many actions may be brought. Although additional workload could be generated, it is not expected to be significant and existing court staff would absorb it. Forfeitures collected as a result of this bill are divided equally between the state and the county.

Long-Range Fiscal Implications
